**Billing is available annually, semi-annually, quarterly, and monthly. Payments can be made by check or credit card (American Express, Visa, MasterCard, & Discover).**

#### Membership Category Definitions:

- (1), (1A) **M&M (Mortgage & Maintenance)** is used for paying the mortgage and creating a cash reserve for major capital outlays for our facilities. M&M is \$750 for 7 years, and then is reduced to \$190.
- (2) **Family** is defined as two persons residing together (regardless of religious affiliation) between the ages of 32 and 64, with or without dependent children.
- (3) **Single** is defined as an unmarried person between the ages of 32 and 64, with or without dependent children.
- (4) **Senior Single** is defined as a person age 65 and older.
- (5) **Senior Couple** is defined as two persons residing together (regardless of religious affiliation) where at least one member is age 65 or older. The parent or parents of either one of the couple shall be included in their membership if they reside with the senior couple.
- (6) **Associate Membership** is available only to members in good standing at another synagogue. This category does not include High Holy Day tickets (except via URJ reciprocity) or voting rights. (Please advise us of your primary affiliation.)
- (7) **Young Member Single** is defined as a single person between the ages of 21 and 31 with or without dependent children. **Young Member Family** is defined as two people

residing together (regardless of religious affiliation) where at least one is between the ages of 21 and 31, with or without dependent children.

- (8) **Student** is defined as a person between the ages of 21 and 31 attending school on a full time basis with verification of paid tuition and current school identification. **Student Couple** is defined as two people residing together (regardless of religious affiliation) where both are students.

Questions regarding membership categories shall be resolved by the Board of Trustees of Temple Kehillat Chaim.

### **Religious School Tuition\***

- *Non-refundable, non-transferable \$50 registration fee, with \$100 maximum per family*
- Pre-K - \$300 per student (Sunday – only)
- Kindergarten - Second grade: \$610 per student (Sunday-only)
- Third - Seventh grade: \$980 per student (Sunday-only)
- Chai 5 - Eighth & Ninth grades: \$525 per student
- Confirmation – Tenth grade: \$600 per student

\*All Religious School tuition is due in full prior to the start of the school year or in 8 payments by credit card August 15 through March 15.

### **B'nai Mitzvah Fees**

- B'nai Mitzvah fees of \$995 to be divided into thirds, with the first third due when the B'nai Mitzvah date is assigned (5<sup>th</sup> grade), the second third due in the 6<sup>th</sup> grade year and the last third due 8 months prior to the B'nai Mitzvah date. This fee covers additional expenses and is in addition to Religious School tuition.
- Minimum Kiddush fee of \$125 due 30 days prior to event.

All payments to Temple Kehillat Chaim will be prorated if applicable.
